The Board duly approved the constitution of its composition. The Chairperson proceeded to introduce the members of the Board of Studies and elucidated their professional profiles.

4. Presentation of Institution Profile

The Chairperson proffered a comprehensive overview of Arjun College of Technology, delineating its evolution, institutional growth, academic architecture, regulatory approvals, facilitatory standings, infrastructural endowments, and NAAC accreditation credentials, thereby underscoring the institution's unwavering commitment to scholastic pre-eminence and perpetual quality augmentation.

6. Discussion on Regulations R2021 and R2025

7. Curriculum and Syllabi – Adoption and Implementation

The Board accorded its formal approval to the syllabi for Semester II (under Regulations R2025) and Semesters IV, VI, and VIII (under Regulations R2021), endorsing their implementation. The Board resolved to adhere scrupulously to the Anna University-prescribed curriculum for the April–May 2026 examinations. Furthermore, the formulation of the bespoke Arjun College of Technology Autonomous Regulations R2026 curriculum was deferred to the next meeting

8. Conduct of Examination & Evaluation

It is proposed to conduct the Autonomous Examinations & Evaluation from the session April/May 2026 onwards following the Regulations R2021 (for the 4th, 6th, and 8th Semesters) and R2025 (for the 2nd Semester) of Anna University. In addition to the regular examinations and evaluation, all the arrear examinations of the students who are present and undergoing studies as on date in the college also to be conducted as autonomous.

9. Finalization of Examination Schedule

It is proposed to conduct practical examinations from 16.05.2026 & theory examinations from 23.05.2026.

10. Question Paper Setting and Evaluation Procedure

The Board recommended adopting standardized guidelines for question paper setting to ensure comprehensive syllabus coverage, appropriate alignment with course outcomes, incorporation of Bloom's Taxonomy levels, and a balanced distribution of difficulty levels. The Board also deliberated on strengthening the evaluation process to ensure uniformity, and facilitate timely preparation of results.

11. Malpractice Prevention and Disciplinary Guidelines

The board recommended various initiatives for malpractice prevention to ensure fair and transparent conduct of examinations.

12. Procedure to be followed for Moderation and Result Process

The Board recommended a detailed deliberation on the moderation process to ensure consistency and impartiality in evaluation.

- The institution proposes to follow the Regulations R2021 (for 4th, 6th and 8th Semester) and R - 2025 (For 2nd Semester) of Anna University for the conduct of the April / May 2026 Even Semester Examinations for the Department of Electronics and Communication Engineering, as the autonomous status was granted by the University subsequent to the commencement of the current semester.
- The **practical examinations** are scheduled to be conducted from **16.05.2026 to 21.05.2026**, and the **theory examinations** are planned to commence from **23.05.2026** onwards.
- All examination-related activities (Theory and Practical) including procedures during question paper setting, conduct of examinations, evaluation of answer scripts, and publication of results will be carried out strictly in accordance with the rules and regulations of Anna University by the College.
- The question papers will be set 50% by external faculty members of Autonomous colleges affiliated to Anna University & 50% by internal faculty members with minimum 10 years of teaching experience.
- The examinations will be conducted by Arjun College of Technology in strict adherence to Anna University norms, including seating arrangements, hall allocation, invigilation, and other exam related procedures.
- Second BoS meeting will be held in third week of June 2026 for detailed suggestions, modifications, and academic improvements for the upcoming semesters and for the formation of new regulations R2026 of Arjun College of Technology.
